Subject: EMWD Construction Near Your Residence

Dear Neighbor:

On behalf of Eastern Municipal Water District (EMWD), we would like to offer a courtesy reminder regarding construction activities near your residence in Moreno Valley.

In the coming weeks, EMWD will begin construction on a groundwater well along **Los Cabos Drive, between Plaza Sonada Way and Iris Avenue at Victoriano Park**. This well is an important part of our Perris North Groundwater Program, which will help provide long-term water quality and supply benefits to the region.

EMWD will install temporary fencing and 24-foot-high sound walls around the project site. These temporary structures, along with sound and vibration monitors, are designed to limit noise and light coming from the work site.

In preparation for construction activities, crews will also be removing a small portion of landscaping, including trees, at Victoriano Park. This landscaping will be restored after construction is completed.

In early May 2021, the first interval of the well drilling process will begin and requires **24-hour per day operations** to ensure the structural integrity of the groundwater well. The well drilling process will be completed in two intervals, each lasting several weeks. The noise emitted from well drilling is similar in decibels to that of a running shower or low-level industrial hum.

Following the completion of drilling activities, EMWD will bid a second project to construct the piping and motors needed to operate the well. That activity will be limited to daytime hours only. Daytime working hours are currently set from 7:00 a.m. to 5:00 p.m. and are subject to change.
