The customer at the above address has requested to participate in Eastern Municipal Water District’s (EMWD) Residential Drip Retrofit Kit Program. Customers who wish to participate in this program are required to meet the following requirements: (1) customer must have a history of current bill payments with EMWD for a minimum of 12 months; (2) customer agrees to pick up kit at only the locations listed on the voucher; (3) customer agrees to provide post-installation pictures; (4) customer agrees to a post-installation onsite verification; (5) customer agrees that EMWD is not responsible for water bills or water usage resulting from the installation of the kit, programming of irrigation clock or any malfunctions/defects of the product; (6) customer agrees that EMWD is not responsible for any product defects, customer is responsible for notifying the irrigation retailer the kit was received from or the Rain Bird Company immediately; **(7) If customer does not install kit or return kit to the irrigation retailer within 45 days of purchase, customer will be charged the full amount of the Retrofit Drip Kit (\$199).**

I understand that the above information is required, in order for EMWD staff to review my request and determine the eligibility of my account for participation in the Residential Retrofit Drip Kit Program. I have completed the above information and affirm that I am the above account holder and the information contained herein is complete and accurate. I further understand that all information is subject to verification; and submitting this request does not guarantee participation; and that the program has limited funding and will be offered on a first come-first served basis to a limited number of homeowners. _____ **(Customer Initials)**

This agreement gives EMWD’s Employees and Representatives permission to enter and to be on the customer’s property for the sole purpose of conducting one or more of the following; (1) verification of the installation of the Residential Drip Retrofit Kit, (2) all components of the kit have been installed, (3) follow-up inspection, (4) irrigation controller has been adjusted.

Customer agrees to defend, indemnify, protect and hold EMWD and its agents, officers, and employees harmless from and against any and all claims asserted or liability established for damages or injuries to any person or property which arises from or are connected with or are caused by the acts or omissions of the customer or from conditions on the customer’s property; provided, however, that customer’s duty to indemnify and hold harmless shall not include any claims or liability arising from the willful misconduct of EMWD, its agents, officers, or employees in performing the verifications or supplying materials or equipment to the customer. _____ **(Customer Initials)**
