

Well 202 Site Address: 1305 E. Seventh Street, San Jacinto, CA 92583

Directions From HWY 74 East: Turn north on N. San Jacinto Street. Continue north on N. San Jacinto Street until reaching Esplanade Avenue, then turn east on Esplanade Avenue. Continue east on Esplanade Avenue to Hewitt Street, then turn north on Hewitt Street. Continue north on Hewitt Street to the intersection of E. 7th Street, then turn east on E. 7th Street. Continue east on E. 7th Street to Donna Way. The pre-bid meeting will be conducted at the Well 202 site at the intersection of E. 7th Street and Donna Way.
