Project Description:
The Project consists of construction of a 1.79 million gallon (MG) potable water storage tank and associated infrastructure that would provide potable water service to the Belle Terre community as planned by SP382S1. The Project would also include two (2) 18-inch diameter water pipelines, a detention basin, and a concrete-lined flat bottom ditch. Additionally, a free-standing communication antenna tower, approximately 40-feet high, would be constructed on the Project Site just southwest of the tank. Construction is anticipated to occur during the months June through September and between October through May taking approximately one year to complete.
