Subject: Upcoming EMWD Construction Near You – French Valley Recycled Water, Phase II Pipeline Installation Begins

Dear Neighbor:

In a letter dated October 18, 2022, Eastern Municipal Water District (EMWD) provided information about an upcoming construction project in your area.

This follow-up communication is to provide you with an update on Phase II of the French Valley Recycled Water Pipeline Project (Project).

Background: The Project consists of installing approximately 12,300 feet of recycled water pipe along several streets southeast of Winchester Road in the French Valley community. This work is part of a three-phase project necessary to convert key locations to recycled water for landscape irrigation purposes instead of using drinking water. Phase I of the project was completed in 2018, and the project timeline and alignment for Phase III is still under review.

Progress To-Date: The Phase II Project is approximately **27% complete**. Crews continue working on pre-construction activities which has required temporary and intermittent traffic control set-up in sections along the Project alignment. Pre-construction activities are set to conclude before the end of the year.

Upcoming Project Activities: In the coming weeks, EMWD will begin pipeline construction work for the Project on **Pourroy Road, north of Cinzia Lane**, and will move north towards Brookfield Park.

During construction, the community can expect:

- Accommodated access to and from side streets, parks, and residences along the Project alignment during construction hours;
- Full traffic control in place from 7:00 a.m. to 4:00 p.m.;
 - Some traffic control measures may be left in place overnight during the work week;

- Anticipate traffic delays, detours, lane closures, and traffic flaggers throughout the duration of the Project;
 - EMWD asks that motorists please follow all traffic control measures to ensure the safety of crews and the community.
- Large machinery used and secured safely in the public right-of-way;
 - Temporary no-street parking during construction hours;
 - Temporary closure of pedestrian access to sidewalks and bike lanes;
 - Temporary increase in noise, dust, and vibrations from construction work;
 - After each workday, crews will be leaving streets in a drivable state with final paving set to occur at the conclusion of the Project.

The estimated completion date for the Project is Fall 2023. EMWD is working closely with the County of Riverside, Temecula Valley Unified School District, Valley-Wide Recreation and Park District, and surrounding stakeholders to keep community impacts to a minimum; more information can be found on the attached fact sheet.
